About the program

Small commercial customers who reduce, reuse and recycle materials similar to that of a residential household, can apply to use the household hazard waste and blue cart recyclables areas at 4R Winnipeg Depots for an annual fee.

Accepted materials

Small commercial customers may only bring the following materials to the household hazardous waste building and blue cart recyclables areas:

- Household chemicals
- Fluorescent lights
- Propane tanks
- Paint
- Herbicides/pesticides
- Flammable liquids
- Oil
- Batteries

- Newspaper
- Household paper
- Empty cardboard
- Empty plastic containers
- Empty metal cans
- Empty glass bottles/jars
