EXPLANATION OF THE REVISION SUMMARY

(The most recent revisions are highlighted yellow in the Specifications)

Revised Specifications

- CW 3110-R19 Sub-grade, Sub-base and Base Course Construction
- Section 1.2 Added definitions for "Crushed Recycled Concrete", "Deleterious Material", and "Friable".
- Section 2.1 Substituted "deleterious" for the word "foreign".
- Section 2.2 Added Atterberg Limits Test method to define how liquid limit and plasticity index are tested.
- Section 2.6 Changed section heading to "Quality Assurance Testing" and added a clause requiring that copies of all test reports to be sent to the Research and Standards Engineer.

CW 3310-R16 - Portland Cement Concrete Pavement Works

- Section 10.1 Added a clause requiring that copies of Plant Batch tickets be sent to the Research and Standards Engineer upon request.
- CW 3326-R2 Detectable Warning Surface Tiles
- Section 1.4 Deleted SD-229AC Layout Option 3.

For SD-229AA - Substituted the words, Layout Priority 1 for Layout Option 1

Added new Standard Detail, SD-229AB – Detectable Warning Tile for Intersections, Layout Priority 2.

Section 3.1 Deleted Layout Option 1, 2 & 3. Substituted Layout Priority 1 & 2.

Added a clause to prohibit placing detectable warning surface tiles to create crossing paths of travel on the street side of the tiles. (Ref: SD 229-AB)

- Section 3.3 Deleted clauses .3 & .6
- Section 4.1 Revised the pay item for detectable warning surface tiles. 300x300mm tiles are deleted.

Section 5.2 Substituted "350" for "300", as the maximum size for rock riprap.

- SD-229AA Revised Standard Layout detail by changing 400 MIN to 300MIN.

Revised the title by changing "Layout Option 1" to "Layout Priority 1"

SD 229AF - Revised the standard detail by changing "400 MIN" to "300 MIN".

New Standard Detail

SD-229AB - Added new standard detail; "Detectable Warning Surface Tile for Intersections, Layout Priority 2".

Deleted Standard Detail

SD-229AC - This standard detail was deleted because it depicted 300 x 300mm tiles. 300x300mm tiles are no longer approved for use.
